Students eligible for an Indiana Choice Scholarship must hold legal settlement in the state of Indiana; be ages 5-22 by October 1, 2023; meet the income requirements (on the reverse side); and be registered at an approved non-public school. To apply, complete this application and return it to St. John's office along with your 2022 form 1040 tax return showing your Adjusted Gross Income and dependents claimed.
